A: An excess applies to each and every claim made, irrespective of the cause of damage. As the damage has occurred on two different dates, each attack would be classed as a separate loss and carry its own excess.


How do we value your church?

Tips for a safe baptism

A baptism is a wonderful and important part of the Baptist journey of faith and the baptismal pool is essential to the ceremony. As a piece of equipment, your church should ensure that precautions are in place so that ceremonies take place safely for everyone involved.



The two key concerns are water and electricity – and we all know they don't mix very well!

Microphones are often used during a ceremony, by the Minister, the person being baptised and possibly others. There is also likely to be equipment to support the use of microphones such as amplifiers, speakers and cables.

It's vital to keep these away from the baptismal pool and only use wireless microphones within two metres of the pool. You certainly want to avoid using mains microphones or you could have a very serious incident.

When using water, there are a number of considerations including the risk of slipping, legionella and damage

caused by the escape of water. To avoid these hazards, ensure puddles of water caused by splashing and walking are mopped up quickly from the baptistery, changing area and pathways. Regularly check how and where the water is stored, and clean the water. You should also take care not to overfill the baptismal pool.

Where full body immersion takes place, consideration must be given to the safe handling of the person being baptised, whilst at the same time ensuring that the Minister also remains safe.

Is your church ready for winter?

As the nights draw in and we pull on extra layers, our churches need the same attention. They need to be warm for the comfort of their members, but also for the protection of the building against deterioration.

Pipes should be lagged to reduce the chance of bursting due to freezing temperatures, and causing water leaks that will damage furnishings, electrical equipment and more. Paths should be protected by a layer of grit and cleared of excess water and leaves that could cause a nasty slip and fall.

Your boiler and heating system may be due its annual visit from a qualified engineer to ensure it's working efficiently and safely. Your gutters and drains also deserve some attention to free them from cold, damp leaves that could be blocking them up and causing damp and water ingress.


A popular extra layer during colder weather is the addition of temporary heaters. Take care with where they are positioned and ensure they have been tested within the last 12 months.

Baptist Insurance Grants helps *The Turning* transform disciple-making with web-based App and localised church training

Baptist Insurance Company's grant to The Turning has funded development of a web-based App to support disciple-making throughout Europe. The Turning, an evangelistic campaign begun by Reverend Yinka Oyekan and The Gate Baptist Church Reading, aims to equip Baptist believers to share their faith with others.

The way of making disciples is cultural, local, and differs from place to place

Reverend Oyekan said: "Many people don't feel confident to disciple others because they're scared 'they'll get it wrong'. *The Turning* is a movement to train, support and share the making of disciples together. We train local people through church hubs in each community, so the message remains the same but disciples share it appropriately in their own communities."

The Turning's App has been invaluable in training disciples to reach out to others on the street. It can be downloaded for free, includes an online bible and daily devotions, and provides a secure way to collect people's details, so trained evangelists can follow up.



To date, the App has been translated into Spanish, French and German

"It's just crazy to think that a little Baptist Church in Reading can do all this," said Reverend Oyekan, "The whole Baptist family has stood with us and supported *The Turning*. Together, we've transformed thousands of lives and added 17,000 disciples to our family in a few short years."

"We're really excited to see the impact of *The Turning*," said Anne Bishop, Chair of the Baptist Insurance Company Grants Committee, "and feel privileged to have played our part in enabling it to disciple those who respond to street events."

Q: Can I change our contact details as I am no longer the contact for our policy?

Q: Are my contents covered by my home insurance when away from home?

A: If you have opted for this cover, it is found under the 'portable items' section of your policy. Cover is provided for your portable items anywhere in the world up to 90 days in total during the period of insurance. Items valued over £3,500 will need to be specified on the policy individually.

Q: Are the contents in my garage covered in my home policy?

A: Yes. The contents in your garage and any outbuildings will be automatically covered up to £5,000.


