Welcome to this special edition of Expressions, where we are sharing with you a few of the many exciting stories from those who have benefitted from our long-running grants programme!



These grants come from the way we operate - instead of making profits which are then paid out as dividends to shareholders, we return any surplus to the Baptist family to help you reach out to those around you. It's amazing to see how often a relatively small amount of money can make a big difference to those blessing their communities by being 'church' in places where there are few other opportunities for people to experience God's love.

Inside this special edition you will find a variety of stories demonstrating the creativity and commitment of just a handful of the groups and churches who have benefitted from our grants over the years. For example, Marske Community Church, on the North Sea coast near Middlesbrough, where during the pandemic - the worst imaginable time! - a group of local Baptists wanted to reach out to their community and, as a result, have become a place where people know they can come and experience God's love for them in practical and pastoral ways. An initial grant of £9,000 helped them to establish the church, building strong links with a wide range of local groups and ministering to people of all ages - see more inside.

Our hope is that reading these stories will inspire you to find ways of reaching out to your local community and encourage you to apply for a grant from us. It is relatively simple, and our website includes guidance on the kind of things we will

(and won't) fund, along with a short application form. If your proposed activity meets our core criteria, we then ask for more details so that our grants committee can give your request prayerful consideration.

# Unlocking funding to 'green' your churches

Climate change is one of the biggest and most important issues facing the world today – how can churches respond? Given that one key to lowering carbon emissions is reducing energy consumption (and hence bills) there should be a win-win, but where do you start?


Begin by assessing how green your church already is and from that produce a plan for improving it. If you are unsure where to begin, The Baptist Union Environment Network initiative brings together resources and stories to assist your church. Use tools like the BMS Carbon Calculator, which can help assess your church's carbon footprint and support your improvement plan. Alongside this, develop your story, demonstrating why it is important to the church and how taking steps to care for God's creation is part of your mission.

Identifying potential actions and creating a story can help unlock green funding towards the costs:

- The Government launched its £25.5m VCSE Energy Efficiency Scheme in December 2023, which will fund energy efficiency assessments on charitable properties, then provide capital funding towards improvement work.

- Many local authorities have grant schemes to assist community buildings, including churches, to reduce their emissions - check at county and district level if applicable.
- Community Foundations cover specific geographic areas: www.ukcommunityfoundations.org
- Most grants are thematic and often include carbon reduction funding programmes.
- Many national funders have aims to improve energy efficiency – both National Lottery Community Foundation and Garfield Weston Foundation stress this.
- Look at particular activities or partnerships that could attract relevant funding, such as grants focused on improving energy efficiency in buildings by hosting winter Warm Spaces.

The competition for 'green' funding can be fierce! Start with proper evidence of need and a clear plan then cast your net as wide as possible and focus on the community benefits of reducing the church's carbon emissions.

# With spring just around the corner, your thoughts might be turning to outdoor events

Without proper planning, an otherwise successful church event could be affected by unforeseen incidents. There are lots of things to consider, but the first step in planning any event is to carry out a review of current safety arrangements, even if you are arranging a small event like a coffee morning, this is an important thing to do. #### Things to consider when planning an event

### Check whether you need additional insurance cover

If you're holding an event that is unusual or could be hazardous, please make sure to get in touch with us so we can make sure you are covered. If you're letting the premises to an outside organisation, such as a Scout group, check that they have current public liability insurance themselves, perhaps ask to see a copy of their insurance schedule. We want your event to be a success and we know it's not just insurance you need to consider.
